 - The condition of houses varies on the LHA leases. Can you please advise the standard to which the houses will be upgraded or repaired prior to sale and whether there is a financial limit to the amount that will be spent on houses to bring them to a standard for sale? If there is a financial limit would you please advise the amount?
 - A number of lease entitlement holders have asked if they agree to purchase the
 house will there be the option for them to enter into a sub-lease for the house to
 continue to be managed as a social house so that they do not have to take
 financial responsibility for maintenance? If yes, could you please advise what the
 terms of the sub-lease will be? If no, please advise what other alternative exists
 for them in regard to the house.
 - Similarly, if the lease entitlement holder currently lives in social housing elsewhere
 in the community but is interested in purchasing the social house on their lease
 entitlement and sub-leasing it so that it can continue to be used as social housing,
 will they be eligible to continue to be a social housing tenant?
 - Will there be an option for lease entitlement holders to purchase their house over a period of time e.g. a rent to buy scheme? If so, will their LHA lease be granted before the house is purchased in full?

10.2 <u>Cr Norman Bally's Portfolio Report</u> <u>July/August 2014</u>

This is my report, giving the Council an insight on what is happening around my Portfolio areas for the period up to 20th August 2014.

Men's Group

The men's centre has been pretty slack with no attendance from the community men. The Coordinator has bought some tools & equipment for the men's group, and organized activities such as spear making and carving at the centre, but for some reason no men seem to go up to there. Band practises and traditional dances no longer happening. The good news is that the Men's Centre has finally received their budget and will hopefully be operational.

Housing

This year the Lockhart River Shire team is really busy with a lot of renovations handed over from BAS (formerly QBuild). There are many major renovations along with the contract building of 2 new houses. The Council needs to find out what type of man power we have at the moment, whether we need extra carpenters or not, because we do not have much time to play with before the monsoon starts. The QLD Housing team has put down a really good housing application for the applicants that have applied for new housing here in Lockhart River. The spread sheet will give the Council a very good insight of why that applicant is eligible to get a new house. The housing officer position is still being looked at by the QLD Housing Head Office. The LRASC needs to write a letter about the housing officer position and why it has taken this long to have this position available to the community.

Parks & Gardens

Now that we have a Civil Engineer (Rajah) on board to see that the work crew is working well. The Road Gang are not working all over the place anymore. They are now working according to a plan done by Rajah and he makes sure they complete the task. The work crew are in need of a bigger ride-on lawn mower to keep on top of the slashing and mowing around the Community. The budget for the town beautification for the Community entrance has not been released yet, and we're still waiting for the news of whether the Project will go ahead or not.

My Pathway

My Pathway is working pretty well, thanks to a very good team who are making sure this is what the Community wants. The CAPS meeting is happening regularly. Paul and his boys are helping the Parks & Gardens boys doing a splendid job in keeping the town clean.

- Church Service at St. James Church. Our visitors attended the service and morning tea after the services with some of the elders and parishioners. Visitors were very impressed with the singing of language hymns and choruses.
- Tim and Gina and Daughter Prue arrived in Lockhart with Jim Burgess, they arrived in their own plane. Dottie, Denise, Pat and I met them at the airport, left our luggage at the cabins. We took them to Puuya Centre for our learning circle over lunch; the Bond visitors also joined us.
- BBQ Dinner at the cabins organised by the HACC ladies for the elders, Tim, Gina, Prue and Jim. Tim and Gina were very pleased to talk to the elders and also the leaders to ask questions about their visit to Lockhart River.
- Tim and Family left Lockhart River on their private jet to Brisbane at 12.30pm Tuesday 5th August, 2014.
