Issue: Cape York Employment update on fencing and other projects

CEO expressed some frustration with the lack of action in relation to the aerodrome fencing job. CYE seem more focused on making profit rather than getting some extra hours for their people by expanded activities. Still no confirmation of commitment to this job. Hoping the Bama Services culvert contract will leverage economy of scale against this project.

Issue: Membership of the Lockhart River Social Club

The CEO advised it was vital the new organization, The Lockhart River Social Club, is formed quickly as they will have to apply for the liquor license for the new club. Council recommended the following individuals be approached to provide a good cross section of local interest groups:

Issue: Finance Reports September 2019

The Corporate Services Director advised the change-over in systems continued to cause problems with the production of these reports however significant progress is being made and Stanley will personally attend the November meeting to provide a detailed report to Council.

Issue: Potential loss of the Family Support Program

The CEO flagged the loss of the Family Support Program currently funded by Prime Minister and Cabinet. He advised this \$200K a year program was used to support a range of family related initiatives which will be hard to replace. The impact won't be felt until next calendar year. This fund was the primary source of dance, kids Christmas events, Financial literacy training, and contributed towards the school holiday program and the salary package offered to the Justice Coordinator.
