

**Minutes of the ordinary meeting of the Lockhart River
Aboriginal Shire Council held at the Offices of the Lockhart
River Aboriginal Shire Council on the 17th of November 2015.**

Meeting declared open by the Mayor at 10:15am

Apologies: Cr Norman Bally - Roadworks

Declarations of Conflict of Interest: Cr Paul Piva advised he is conflicted as W&P Machinery Hire Lockhart River has two machines (a grader and a water truck) working on the Old Mission Road under NDRRA REPA works contract 12.15. Cr Piva advised he is a partner in this business. He committed to remove himself from any discussion in relation to this project.

Cr Norman Bally advised the CEO prior to the meeting he may be conflicted as he is driving a water truck for W&P Machinery Hire Lockhart River and for clarity requested the potential conflict be recorded.

Issue: Mangkuma Land Trust

The Mangkuma Land Trust has engaged the pro bono legal services of Heather Robinson of McCulloch Robinson of Brisbane. Council is concerned the continued instability of the MLT must be addressed as they own 90% of the shire. It is in best interests of all parties to invest in bringing functionality back to the MLT.

Council received a briefing on progress against the Portland Road contract delivered through Newton Spencer Contracting from Greg O'Brien.

Council received a further in-depth briefing on the Old Mission Road project delivery including areas of operation that require review.

(N.B.) Cr R. Elu sought leave to excuse herself at 5:25pm for family reasons. Leave was granted by the Mayor.

Discussion continued in detail focusing on risk analysis and critical delivery dates for the Council lead elements of the Old Mission Road. It was noted that some areas were suffering from a lack of command clarity on roles and responsibilities but that over-all the project was being delivered. Greg O'Brien committed to repeat visits prior to wet season shut down to ensure Council was on top of delivery dates and compliance.
