**Call for declaration of conflict of interest:**

Cr Marshall Symonds flagged he may have conflict to declare in relation to the application from Ken Woodhouse to operate a mobile food van in Lockhart Shire but will wait to that agenda item before declaration.

**Issue:**                      **Government Champion visit briefing**

The CEO provided a briefing on the outcomes of Government Champion, Paul Simhauser’s recent visit highlighted by confirmation of securing funding for a 100kwt solar trial at Lockhart River. This trial will be expressed in three sub-trials; on ground collection; rooftop collection; and roof collection and storage. At this point the Council Chambers is the likely rooftop and storage trial site. The end result will be a small annual allocation of power cards to all households in Lockhart.

**Issue:****Water Park update**

The CEO was requested to brief Council on the progress on the Water Park. Council was advised the project was being assessed to see what parts of the project Council could do using our workforce. The CEO is working with Black and Moore on the project delivery methodology and will keep Council informed of developments. Mayor Butcher requested the matter be placed on the agenda for the next public meeting. Cr Bally stressed it was important to get detail of this project out to the public.

**Issue:****Councilor Portfolios**

Discussion occurred on the allocation of specific portfolios to each Councilor. The benefits of this approach were endorsed by all.

**Issue:** Up-date on Kuunchi Karkana Centre  
Cr Dorothy Hobson provided an up-date on preparation for the official opening of the Centre on 23<sup>rd</sup> June. Still required are stone from Garraway, top soil, mulch, seedlings, and fencing. Blessing and soft opening on the 8<sup>th</sup> of May.

**Issue:** Cr Marshall Symonds led discussion on IT support to make sure Councilors remain connected to each other and their constituents. He flagged a Men’s health initiative with an ENT screening led by Apunipima. Cr Symonds requested and was provided a briefing on “Katter Leases” in Lockhart. He also asked for further details on the Pride of Place Program.

**Issue:** Mayor Butcher asked his Council to give thought to a short sharp agenda to guide the first Public Meeting of this term. He then provided a briefing on the recent Empowering Communities forum in Sydney.

**Issue:** Proposed meeting between Council and Mangkuma Land Trust  
Council received correspondence from the MLT Chair David Claudie requesting a meeting between Council and MLT to discuss roles and responsibilities and future partnership arrangements.
