ISSUE:

This meeting has been convened to consider the tender for QRA works from the Pascoe River west to the shire boundary 4.1km before the Wenlock River crossing.

- Tenders were called by Consultant Engineers Black and More on behalf of Council;
- ❖ Black and More provided a tender report and short list;
- Council interviewed the short listed companies, Bama Services, Scotts Earthmoving, and Newton Spencer Contracting with Greg O'Brien of Black and More present;
- Black and More subsequently produced a recommendation report for Council consideration and guidance. Greg O'Brien provided commentary on the report where requested.

Council went through the recommendation report noting a best case scenario would be that Council delivers the project using community resources. Council and the broader community's resources are largely committed, which prohibits using that model. New young entrants to roadworks will need to be developed.

Council noted all three companies had the ability to deliver the majority of works prior to the wet season which is our preference.

ISSUE:
